# **U-CARE project: Alternative Care for Unaccompanied Minors**



Unaccompanied migrant children risk their lives on a perilous journey to Europe, forced to leave everything behind because of conflict, violence famine or persecution. Without parents or any other adult who is responsible for them, they need a safe environment where they can receive adequate care.

The U-CARE project, implemented by IOM in Belgium, Germany and Greece together with Pleegzorg Vlaanderen and Greek NGO ARSIS, aims at strengthening alternative care to better support unaccompanied minors. For more info on the project, click here.

# Did you know... Nowruz

Nowruz is the Iranian New Year, marking the start of Farvadin (the first day of the Solar Hijri calendar, the official calendar of Iran). It is a celebration where its activities symbolise rebirth and the link between humans and nature.

For over **3,000 years over 300** million people around the globe, but mostly in the Balkans, the Black Sea Basin, the Caucasus, Central Asia, the Middle East and other regions, people have been celebrating Nowruz.

Depending which country you are in, this day can also be referred to as: Nauryz, Navruz, Nawrouz, Nevruz, Nooruz, Novruz.

Nowruz means **New Day in Farsi**, a language vastly spoken in Iran, parts of Afghanistan, and the central Asian republic of Tajikistan.

Nowruz starts between the 19th and 21st of March and lasts for 13 days.
