The Global Diaspora Confederation is the world's largest diaspora-led civic society organisation that brings together a variety of diaspora organizations. The concept was introduced at the launch of 2020 Global Virtual Diaspora Exchange Conference organised by IOM and iDiaspora.

In April 2020, the coalition was eventually set up as a message of solidarity to diasporic victims of xenophobia and discrimination due to the COVID-19 pandemic. Through a collaboration with member organisation, humanitarian aid organization, national government and United Nations agencies, the **objectives** for this coalition are to unite, support, develop and promote global diaspora communities.

In 2021, together with IOM and iDiaspora, the Conferedation is organising a new series gatherings experts on these topics to provide information on how to overcome common challenges faced by stakeholders engaging in transnational activities. The first virtual exchange on Building trust took place April 27th; Mobilizing resources takes place on May 27th, followed by a third exchange on **Ensuring sustainability** on **June 17th**. In January this year, IOM Belgium and Luxembourg launched its very podcast series, "Diaspora Insights". Diaspora Insights is a platform by and for diaspora in Belgium where their work and key topics will be highlighted.

The first person to take the mic is the talented Salomé Omanga Ysebaert, an African researcher at the Afrikamuseum in Tervuren, Belgium and a member of the decolonization committee in Brussels. In this visual podcast, she answers questions such as what a diaspora means to her and what a platform such as Diaspora Insights can offer. "(A diaspora) is something important for people who have left their country to find their roots and regain their identity."

This podcast will guide you through the most pivotal points leading to the Genocide against the Tutsi in Rwanda back in 1994. The host of the podcast is Jean-Damascène Bizimana, a renowned researcher on the Genocide against the Tutsi and has been on two genocide-related commissions of inquiry.

#Vaccines: did you know...

... the small pox only exists within laboratory environments? It is one of the two diseases that have been eradicated due to the vaccine against the virus.

... each year, the World Immunization Week takes place at the end of April? This health campaign, lead by WHO, aims at promoting the use of vaccines to protect people of all ages against dispases.

... that a third of the child mortality rates is preventable with a vaccine? Each year about 2.3 million lives are saved by vaccines against tetanus, the measles, diphtheria and whooping cough.

... IOM stands ready to support national authorities and other international organizations with the logistics of the vaccine distribution? The #VaccinEquity campaign calls out all authorities and organizations to equally distribute the vaccines, regardless of one's legal migrant status, because no one will be safe until everyone is.

... the <u>People's Vaccine Alliance</u> is a coalition signed by over 170 current and past nation -and government-leaders that strive for an equal distribution of all kinds of information on the vaccines? They advocate for the patents and intellectual property rights to be shared broadly so all communities can be ensured of the proper creation and distribution of them.
